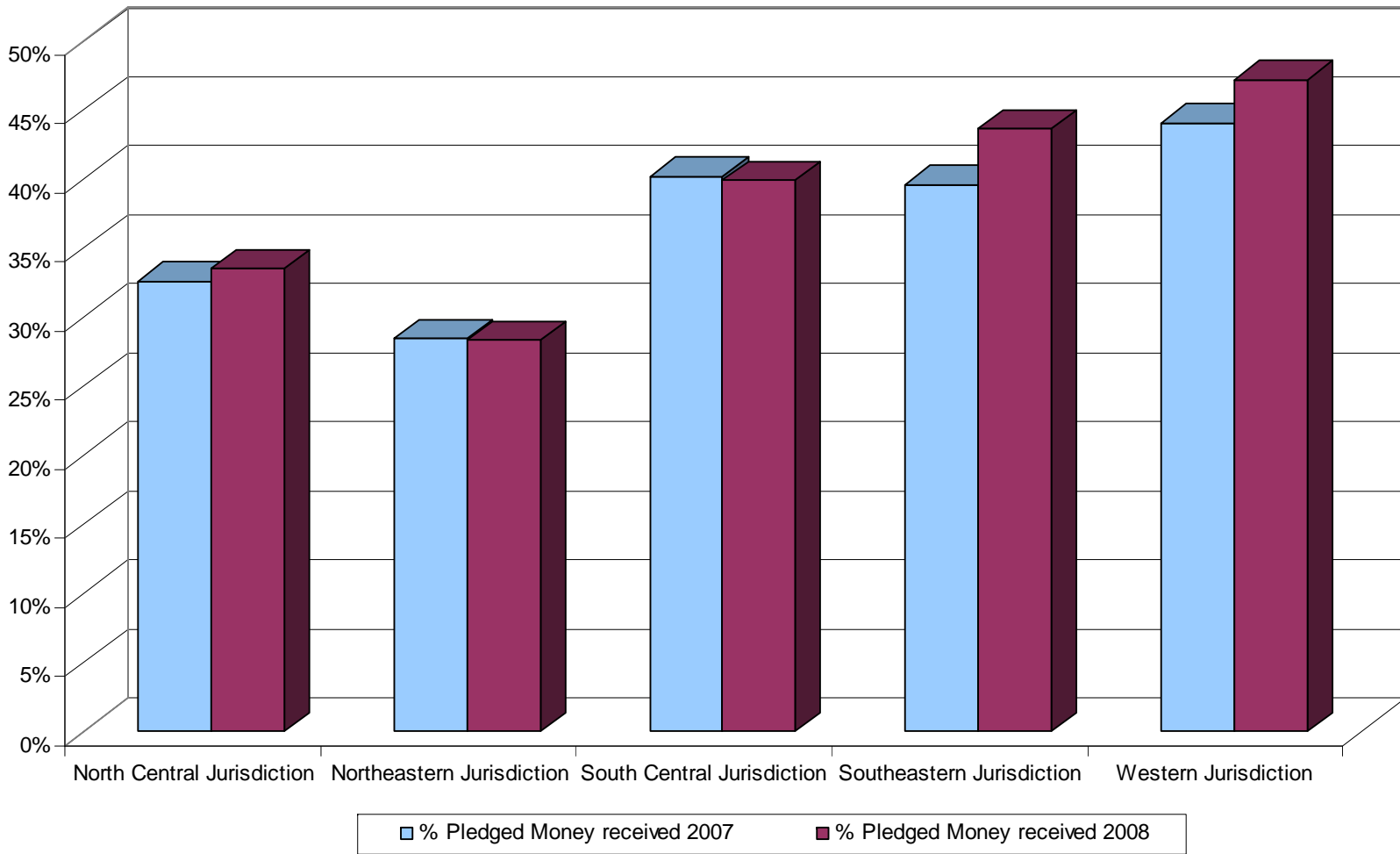

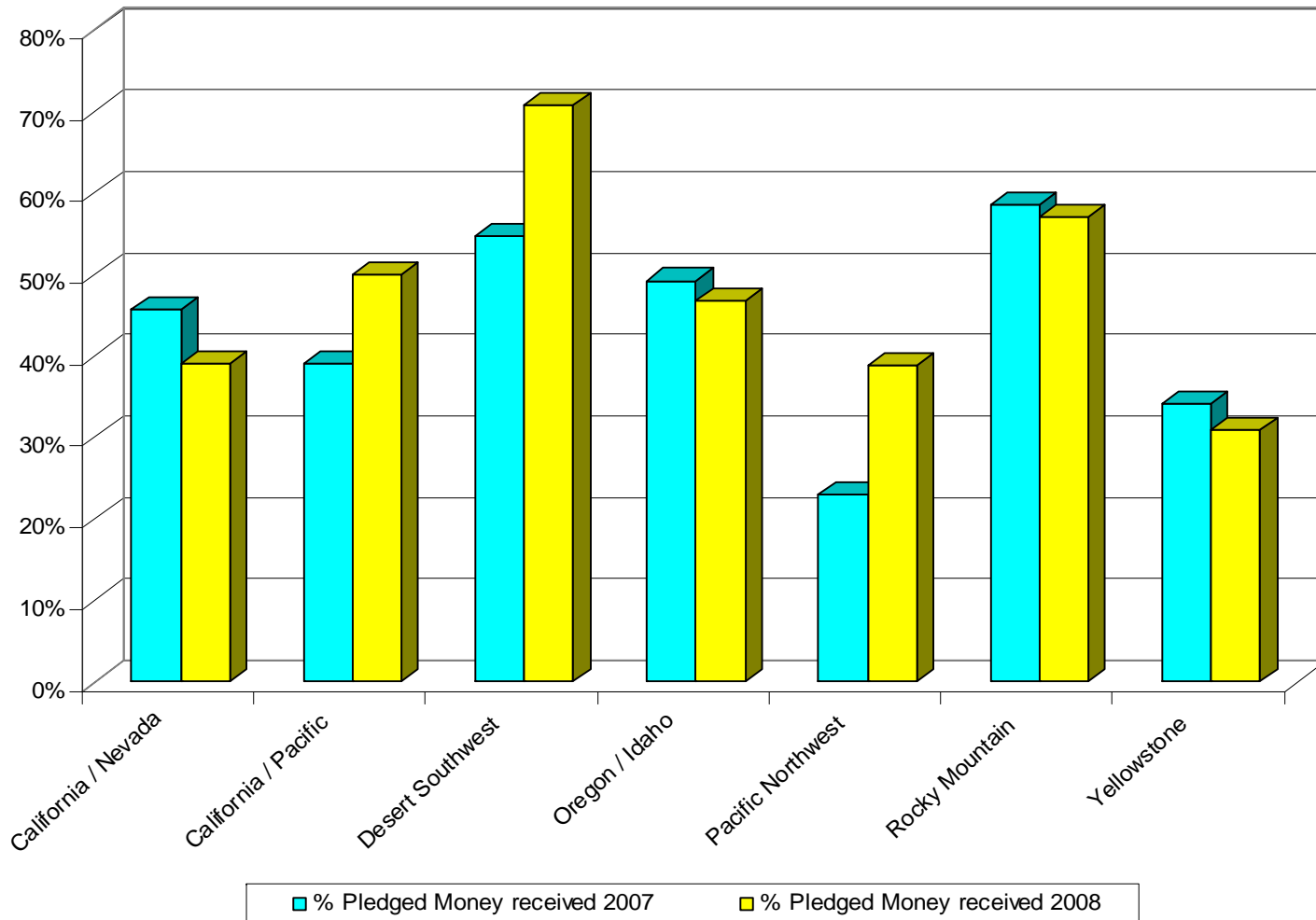


Rate of receipt on a Jurisdiction Giving level



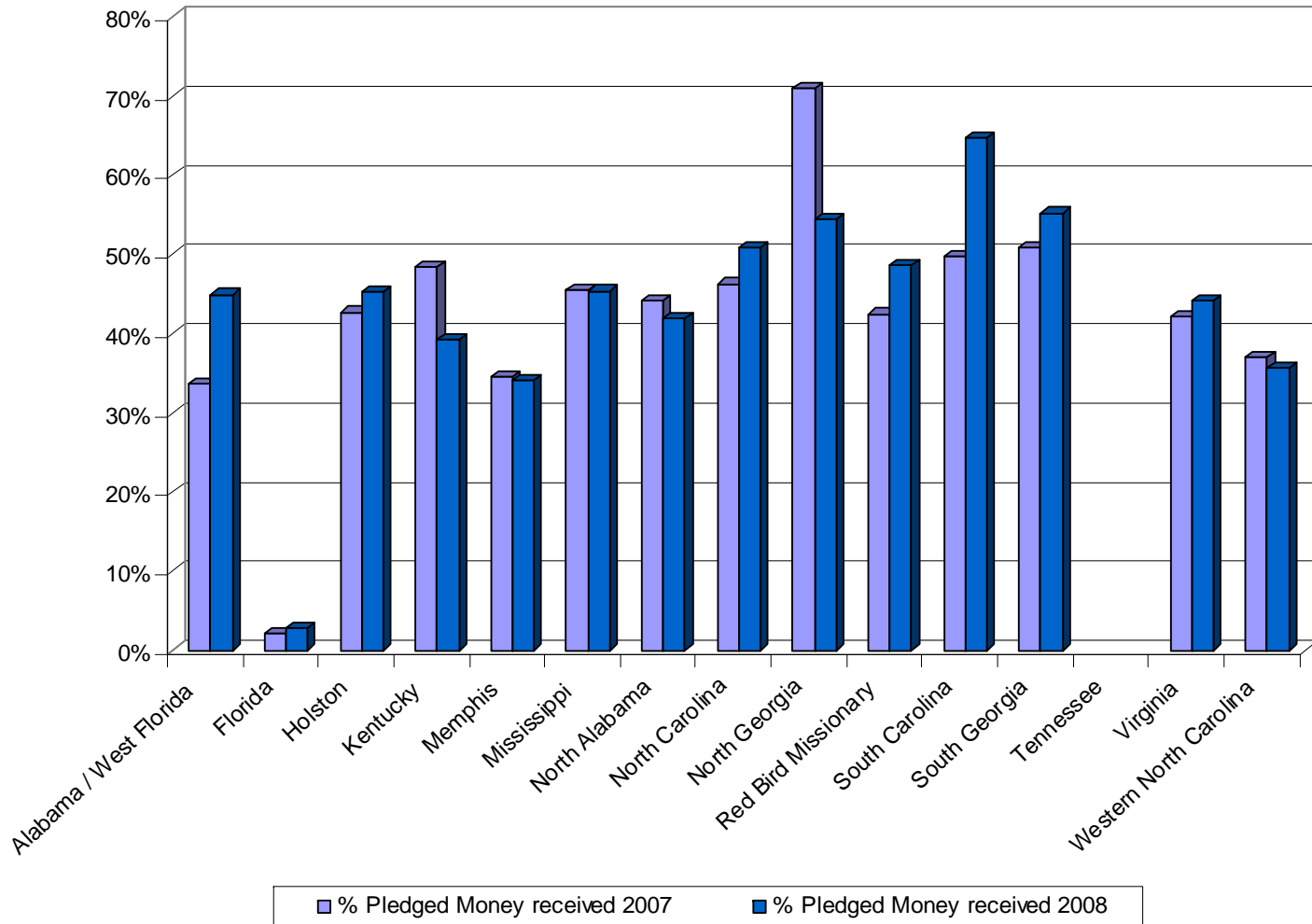


Western Jurisdiction



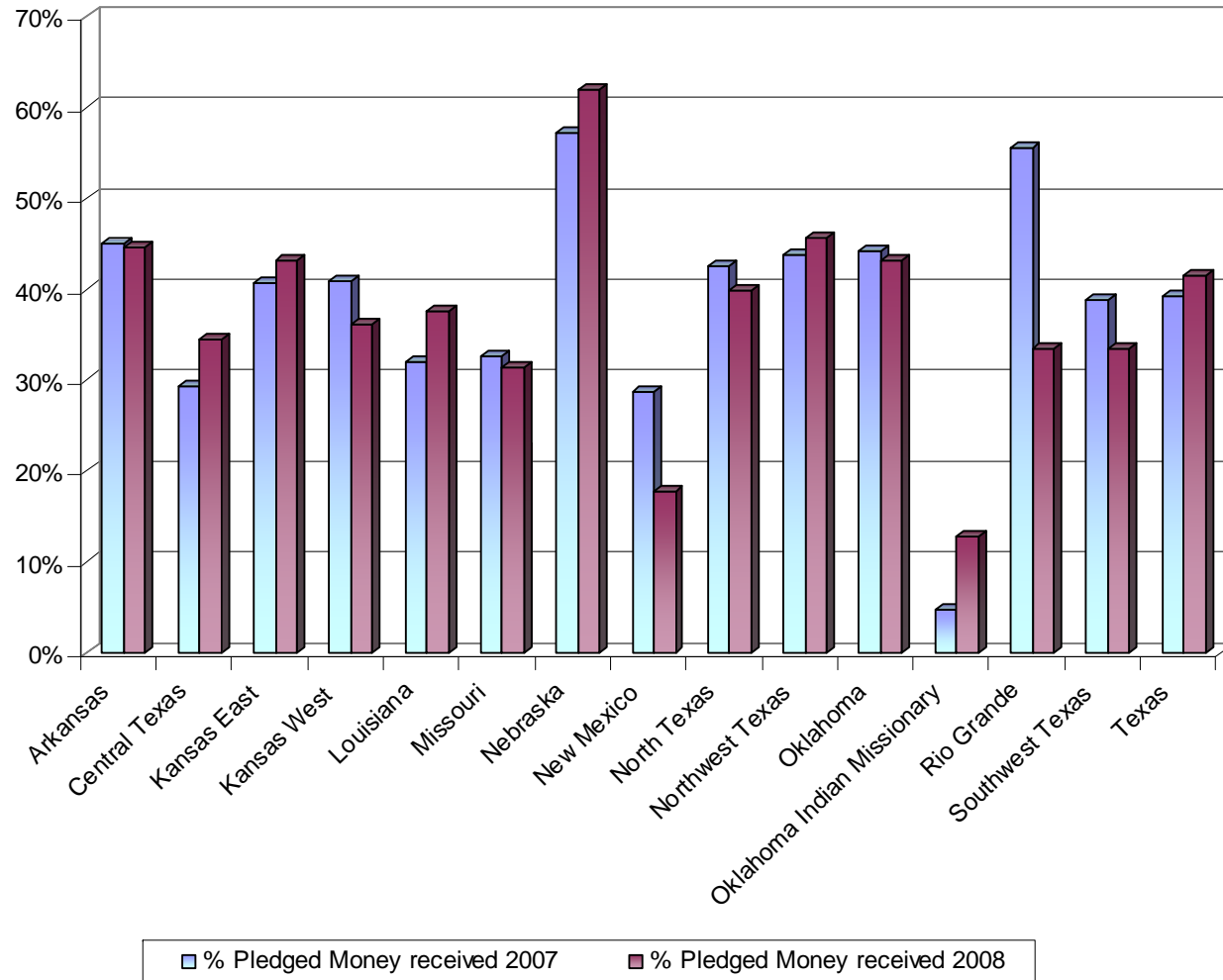


Southeastern Jurisdiction



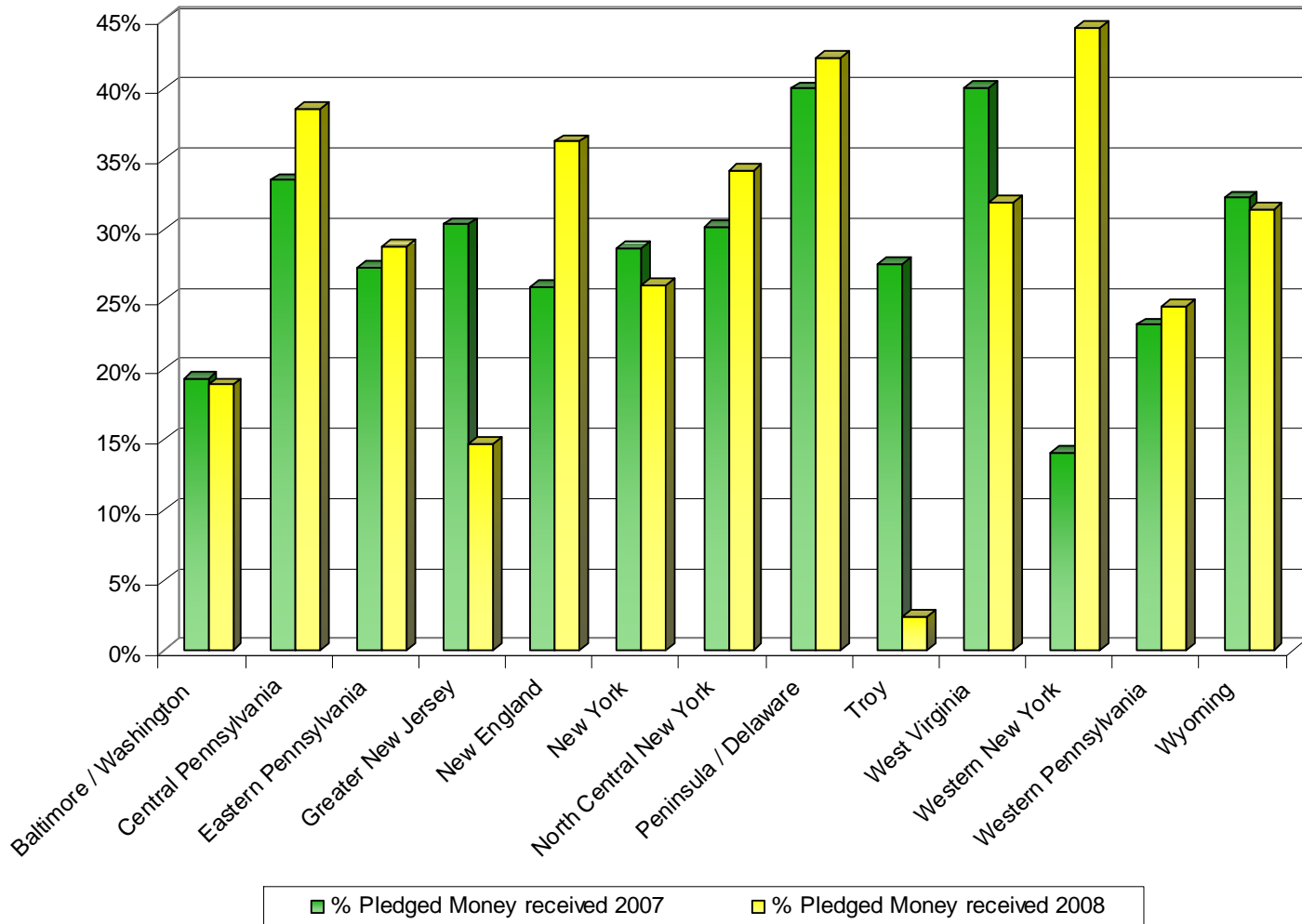


South Central Jurisdiction



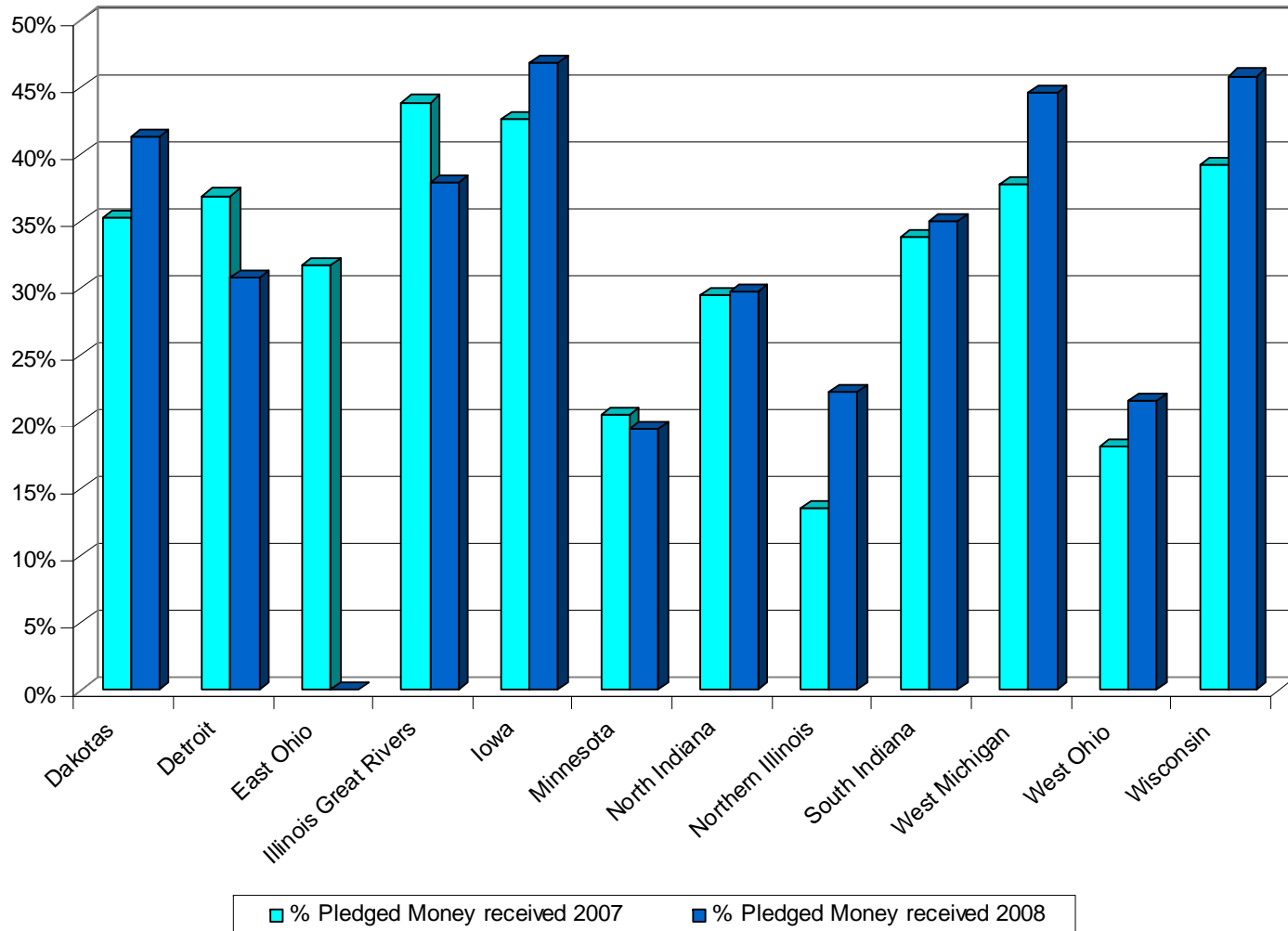


Northeastern Jurisdiction



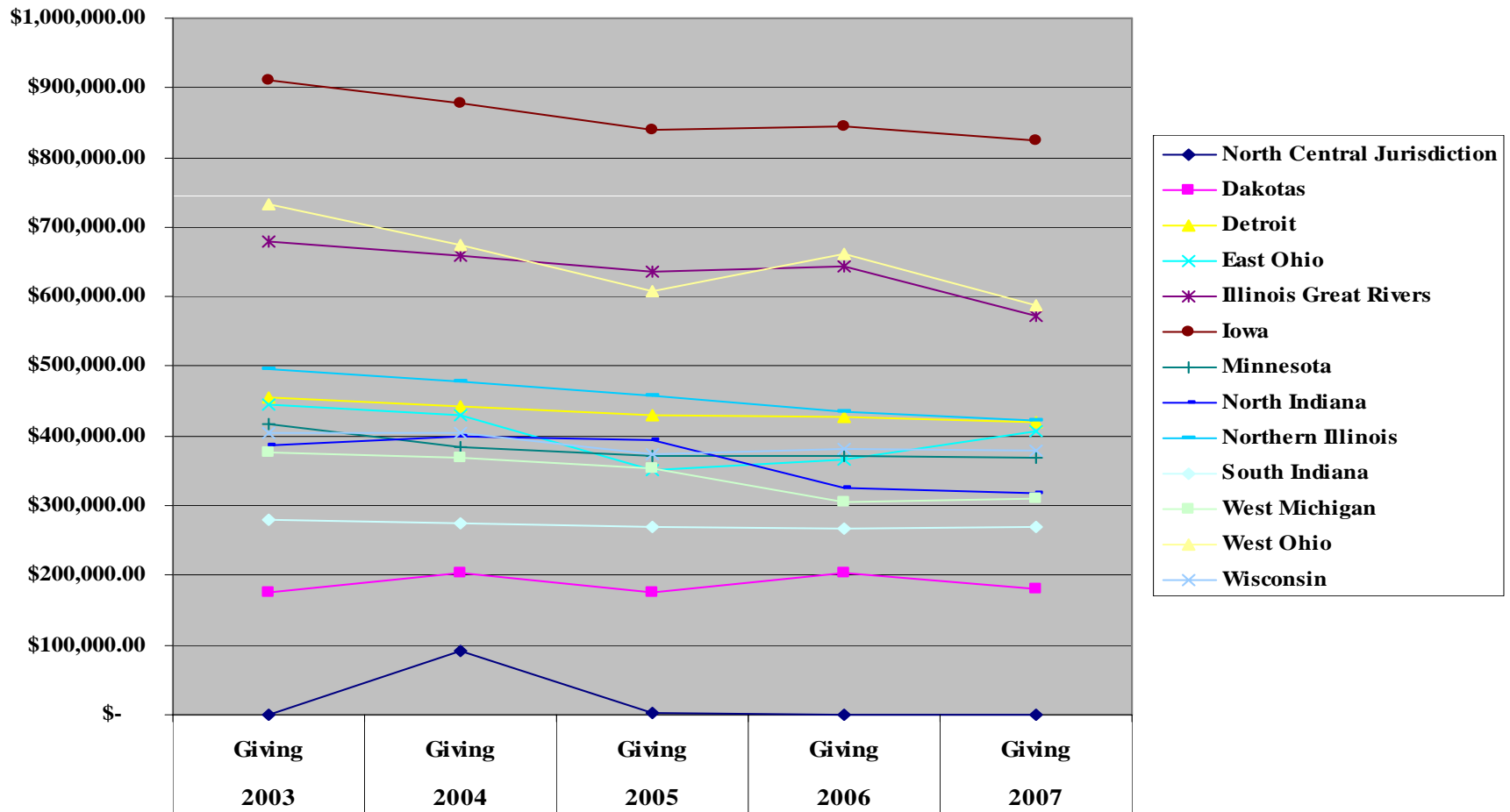


North Central Jurisdiction



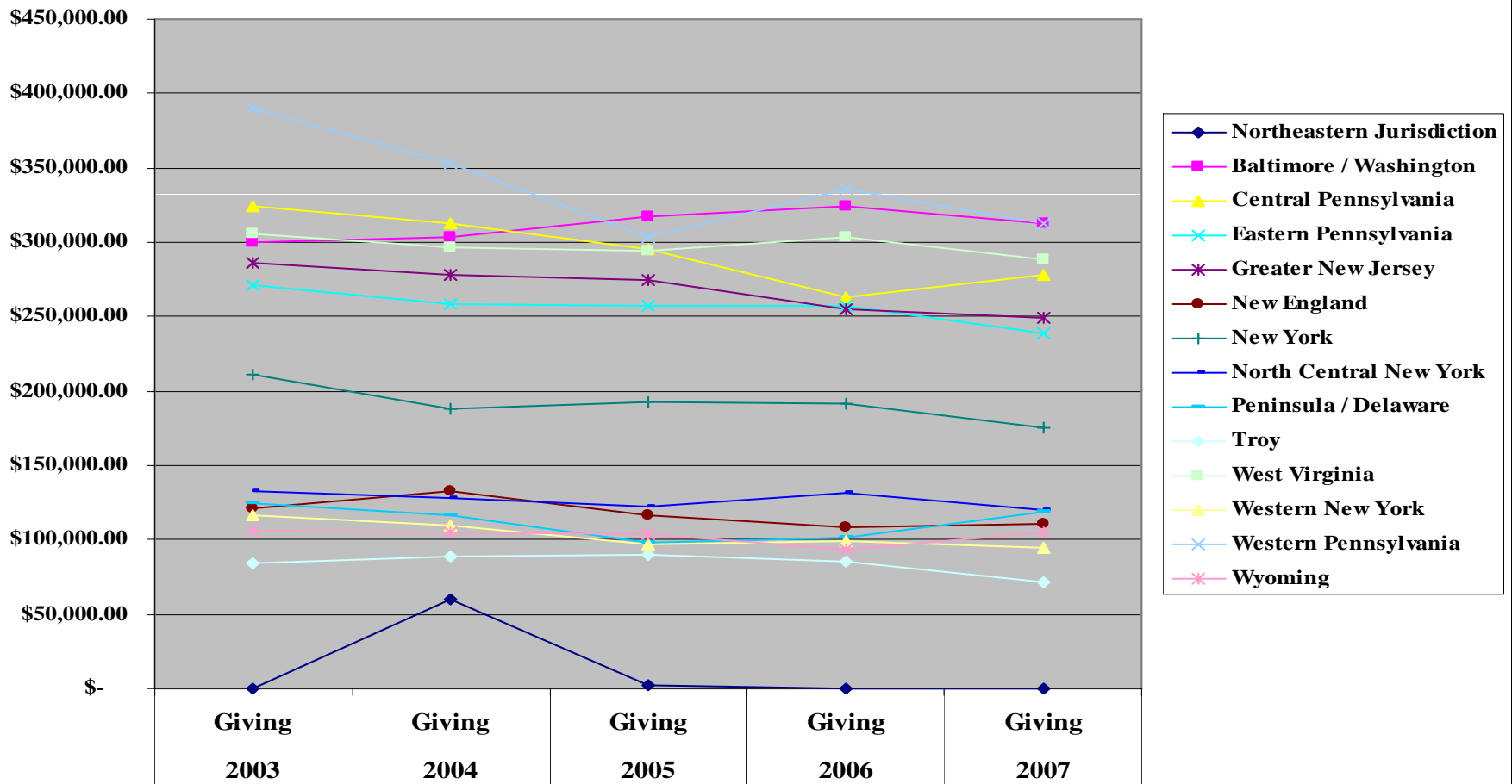

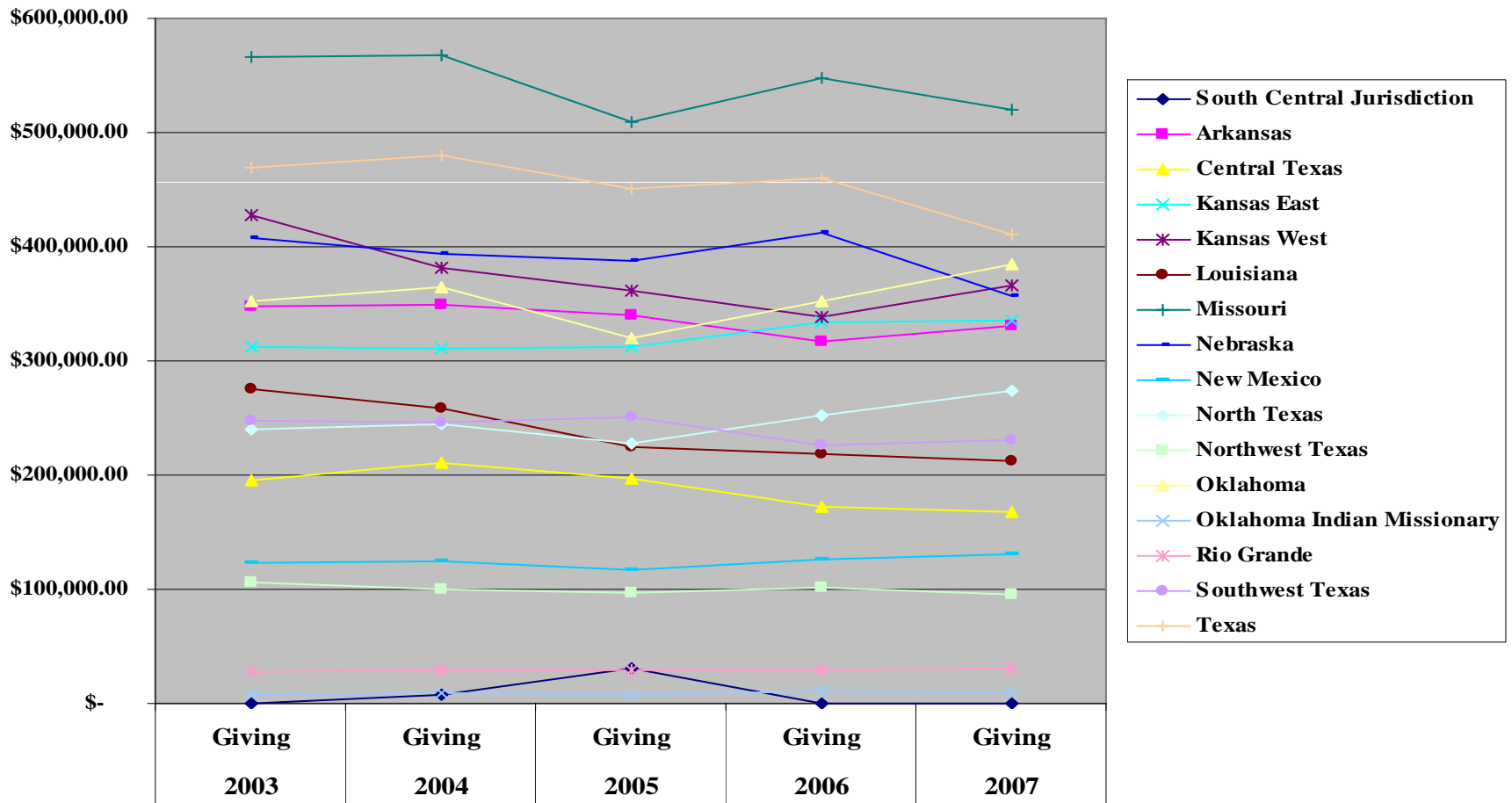


North Eastern Jurisdiction



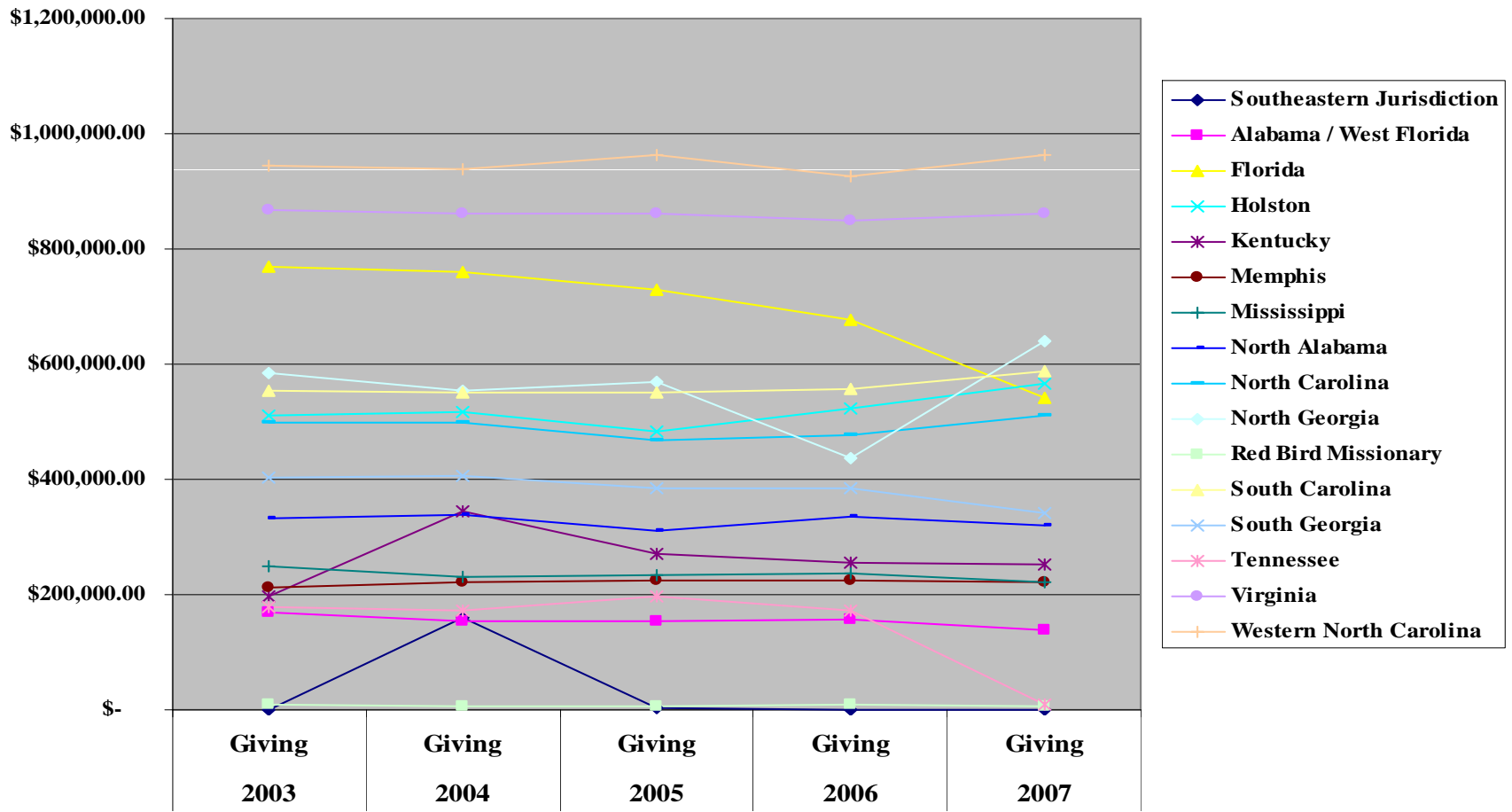


South Central Jurisdiction
